Indra has an important position in the Maghreb, where it promotes technology projects in countries such as Algeria, Libya and Tunisia in fields ranging from sea, air and railroad traffic to the public administration digitization and energy management improvement.

## Leadership in Africa



Indra has been operating in Africa since 1995, with offices in Morocco, Algeria, Kenya, Libya, Senegal, Mozambique, South Africa and Zambia. Its solutions operate in most of the countries with leading projects in key markets throughout the continent's economy.

The company boasts a strong leadership in implementing energy solutions for power companies in Africa, where it has been involved in some of the largest modernization processes undertaken in the last 15 years. Today, Indra's solutions help them manage over 20 million customers.

Indra's strong position in Africa providing air traffic control and management systems and airport services is also noteworthy, as the company has references in over 45 African countries. Indra is presently deploying a network of ADS-B surveillance systems for the ASECNA (Agency for Aerial Navigation Safety in Africa and Madagascar) that will cover a total of 17 African countries and French overseas departments in the Indian ocean. Indra has also recently begun renewing Algeria's entire air traffic management system.

Indra also has a strong position in Africa as an airport service provider. In addition to Morocco, the Ugandan Civil Aviation Authority has commissioned the company to supply and install its advanced passenger information system (InSIGHT) at Entebbe International Airport. Indra's management systems manage Kenya's main airports, where the country's airport operator KAA also uses the Indra system to manage its business. Still in Kenya, Indra has conditioned the air traffic control training center, the East African School of Aviation. Nigeria's largest airline company (Arik) has also implemented Indra's revenue accounting solutions, and South Africa's leading airline company (SAA) has opted for Indra technology to increase online visibility and move forward digitally.

Indra has likewise incentivized the main modernization processes in public administrations such as the project for the Algerian General Tax Directorate (DGI), assisted in the financial management of Zambia by implementing a SAP-based IFMS, and carried out activities at the African Union's headquarters in Addis Ababa. The company also has relevant security projects in the Maghreb, South Africa and East Africa.

Its references in Transport & Traffic, which include operations management system at the Ports of Casablanca, Dakar and Cape Verde, and smart traffic projects for Algeria confirm an activity that is driving Indra's position as a benchmark technology partner for developing the African continent.
