As a result, the number of project and service incidents has fallen, thus substantially improving the quality of product delivery to customers.

In the assessment made, the evaluation team highlighted Minsait's capacity in the estimation, planning, engineering and software development processes. Likewise, it also recognized the best practices in measurement, monitoring and control, risk and opportunity management, quality assurance, configuration management and service catalog management, as well as the testing process and peer review system.
