SEPI, which holds 40%, has assigned its purchase option in 30% to each company.

It also guarantees national sovereignty in the key capacity of domestic, European and NATO encrypted communications, as well as Epicom's technological capacity and financial support, thus enabling its stability and growth and protecting strategic capabilities in relation to national security.
