Looking ahead, the Joint Venture will also develop additional technology solutions to meet the evolving needs of customers and the industry.

By bringing together Indra, NATS and Searidge capabilities, we're combining world-leading AI and Tower expertise to create solutions that help our customers meet the challenges of a rapidly and continually evolving industry."*
